ORDER

In exercise of the powers conferred upon me under rule 34 (1) of Haryana School Education, Rules, 2003, sanction is hereby accorded to grant permanent recognition to Rural School, VII - Janaula, Gurgaon Road, Patauli, Gurgaon for class VIII to XII (Arts, Commerce & Science) under BOSE pattern with effect from 01.04.2015 run by Managing Committee, Rural Shiksha Samiti, Bucholi (Mahendergarh) under following terms and conditions:-

TERMS & CONDITIONS:-

- The permanent recognition is granted that on the subject of the condition that the documents/information furnished by the school will be correct and not subject of fraud in any way. If any information at any stage, is found contrary to the facts the recognition shall be withdrawn.
- The school shall be open for the full academic year and shall not be closed for more than 15 days in any year.
- The school shall be open for the full academic year and shall not be closed for more than 15 days in any year. In case of any change in the fee structure, the school shall be required to submit the details of the fee structure to the Department for the next academic year and will also have printed copies for students of the school.
- Salary shall be paid as per regulations at the time of seeking recognition.
- No institution fee and other charges shall be charged from the students.
- School premises shall not be used for religious, caste, class, place of birth or any other sectarian activities.
- Managing Committee shall be subject to officers' instructions issued in the same premises.
- Managing Committee shall not be allowed to admit students during the academic session without the prior approval of the Department.
- The school shall be open for the full academic year as authorized by the Director (Secondary Education).
- Recognition is granted and will be renewed after every 10 years.
- No financial assistance shall be granted by the Department to the school.
- School premises shall not be used for commercial purposes and any national activities.
- Approval of Managing Committee shall be obtained from the appropriate authority in case of any change in the committee.
- The Managing Committee shall follow the instructions issued by Government/Director from time to time and supply the information to the Dept. Department as required.
- In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provision of the rules.
- School will provide copy within six months after the recognition will stand withdrawn.
- If any information, at any stage found contrary to the facts the recognition would be revoked forthwith.
- That the number of students in classroom shall not be more than the students calculated on the 10 square feet per student for secondary and Senior Secondary Schools and 8 square feet per student in elementary class.
- The managing committee shall abide by the provisions of Haryana School Education Rules 2003(amended) & R.T.E. Rules 2011 and amendments if any thereafter. The Managing shall be liable for disciplinary action in case of violation of any provision of the rules.
