ORDER

In exercise of the powers conferred upon me under rule 34 (1) of Haryana School Education Rules, 2003, sanction is hereby accorded to grant permanent recognition to Sarai School, VII - Jaisauli, Gurdaspur Road, Patiala, Gurdaspur for class 9th to 12th (Arts, Commerce & Science) under EBB pattern with effect from 01.04.2015 run by Managing Committee, Sarai Shiksha Samiti, Bectori (Mahendergarh) under following terms and conditions:-

TERMS & CONDITIONS:

1. The Managing Committee is guaranteed on the above to be informed that the documents submitted by the school are true and correct and no false or forged documents will be submitted at any stage. In case of any discrepancy in the documents submitted by the school, the Managing Committee will be liable to pay the fine of Rs. 100/- per day.
2. The Managing Committee will be liable to pay the fine of Rs. 100/- per day for non-compliance of any condition of recognition and changing the name of the school without prior permission of the Directorate of Secondary Education.
3. The Managing Committee will be liable to pay the fine of Rs. 100/- per day for non-compliance of any condition in case of any change in the fee structure.
4. The Managing Committee will be liable to pay the fine of Rs. 100/- per day for non-compliance of any condition of the school by different Board/University in the same premises.
5. The Managing Committee will be liable to pay the fine of Rs. 100/- per day for starting class during the academic session without the prior approval of the Directorate of Secondary Education.
6. The school will be monitored by the Inspector Officer authorized by the Director, Panchkula authority.
7. Recognition will be discontinued after every 10 years.
8. No financial assistance shall be granted by the Department to the school.
9. School premises shall not be used for commercial purposes and will be used exclusively for educational purposes.
10. Approval of Managing Committee shall be obtained from the concerned authority in case of any change in the committee.
11. The Managing Committee will follow the instructions issued by Government/Board from time to time and supply the information to the concerned Department as required.
12. In case of absence of the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and requirements of any other. The Managing Committee will be liable for disciplinary action in case of violation of any provision of the rules.
13. School will provide compensation to the other recognized schools in case of closure.
14. Every information, at any stage from Committee to the Directorate the recognition would be revoked forthwith.
15. That the number of students in classroom shall not be more than the students calculated on the 10 square feet per student for secondary and lower secondary (Science and IT) based on 100% attendance.
16. The managing committee will abide by the provisions of Haryana School Education Rules (2003) (amended) & RTE Rules 2012 and arrangements & any provision. The Managing will be liable for disciplinary action in case of violation of any provision of the rules.
